Starting Your Dissertation? Rethink Your Lifestyle

You're ready to begin your dissertation, and you deserve congratulations! But realize, though, that your current lifestyle must change.

No Structure

Doctoral students beginning this coveted stage are often shocked at the lack of external structure. No prescheduled class meetings, specific assignments, or grades to

goad you on. No classmates to remind you to tackle the next assignment. You've got to make your own schedule and follow through.

> If you work away from home, you've already got some structure. You can easily figure out your dissertation time: evenings, weekends, and an occasional call-in-sick day.

But if you work at home, the lack of structure can be insidious. In my dissertation coaching practice, one student took a year off to complete her dissertation. But she found that her time was taken up with all the "necessary" nonacademic activities. To her panic, the year evaporated with little done, and she hired me for structure and accountability. So, to prevent such mistakes . . .

Make a List. Draw up your master list of tasks: research into subtopics, outlines of chapters, chair and committee

meetings, university deadlines, actual writing. This list, interminable as it may seem, does have an end. You have it all laid out in front of you and eventually will have the delicious reward of checking items off.

Make a Schedule. You are in training for the dissertation finish line. Allot reasonable times to your training. An hour when you come home from work and two 2-hour stints on weekends? If you work at home, a morning stint, then lunch, even a short nap, and another work session in the evening? Be honest about when you work best.

New Leisure. You'll need to change your definition of leisure. The days of Facebookclicking and evenings of binge TV are over. Many social invitations must be declined or postponed. No more camping weekends or long afternoons at the mall–except maybe when you complete a chapter.

Writing is Thinking: Why It Should Be Integrated Early in the Process of Earning Your PhD

One discussion during a December 2023 TAA Conversation Circle on Writing a Dissertation centered on why writing should be integrated early in the process of earning a doctorate. Three academics who have earned their doctorates weighed in. Here are their thoughts.

Dr. Vernetta K. Mosley, a consultant and writing coach with Cultivate the Writer, explains that in her experience, students in non-writing intensive PhD programs tend to wait until the very end of the program to focus on writing, when it should be part of the process from the beginning.

"It's such a developmental process to master the genre of academic writing that under that time crunch and that pressure of having to produce, the learning curve is so steep that it can be difficult to help them to get up to speed," *continued on page 5*

PRESIDENT'S MESSAGE TAA Reaches and Exceeds 3,000 Member Milestone, Other 2023 Accomplishments

It's my privilege to enthusiastically report that we have had a banner year at TAA in 2023!

Thanks to the tireless efforts of our amazing new Executive Director, Kim Pawlak, and our two other new full-time staff members, Sierra Pawlak, and Kiley Thornton, TAA has been flourishing and the future looks brighter than ever. I'm proud to report that we ended 2023 with a record 3,023 members!

Allow me to highlight some other important accomplishments this year. We sent out a membership survey that revealed that thirtyone percent of responders said they joined the organization for our benefits and services. The top three benefits rated as most valuable were: (1) educational webinars (31%), (2) our annual conference (18%), and (3) our monthly print newsletter, *The Academic Author* (14%). With the emergence of Generative Artificial Intelligence (AI), we formed an AI Committee and sent out another survey to our members. Forty percent of responders reported using AI for various purposes. In response to the question *"How have you used Generative AI?"*, the top three responses were: (1) to make my writing process more efficient (48%), (2) to improve the quality of my writing (35%), and (3) to write a first draft (30%). In our fundraising efforts, Michael Sullivan amazingly donated \$100,000 to fund a matching gift program and a lecture series at the annual conference. This is the largest donation that TAA has ever received. Thanks so much, Michael! With the help of an attorney, we also updated our policies and procedures,




bylaws, and standard forms to be sure that we are in compliance with what other 501 (c) (3) non-profit organizations are doing. In late January, we held a Council Member-Staff Retreat in Nashville to discuss and plan for the future of TAA. Most importantly, we are also very excited to be preparing for our first in-person conference since the pandemic! It will be held in Nashville in June of 2024 and we hope to see you there. We have a fabulous conference planned!

My hope is for TAA to remain true to its mission while also being at the forefront of all issues related to academic and textbook authors. It is truly inspiring to work with such a talented and dedicated group of leaders on TAA's Council. We make a wonderful team and I am excited to do my part to make TAA even better.

Textbook, Academic Authors Report Very Little Communication with Publishers Regarding AI

Eighty percent of respondents to the Textbook & Academic Authors Association's latest survey, "Generative AI, Your Publisher & You," said they have not had conversations with their publishers about their position on AI, their use of AI in their work(s), and/or contract clauses related to AI. The purpose of the survey, conducted between December 12, 2023, and January 8, 2024, was to help members advocate for themselves in conversations with their publisher(s) about generative AI (like ChatGPT) in contracts, policies, and statements.

Of those respondents who have had conversations with their publishers about AI, the majority (56%) said that they initiated those conversations themselves. The primary reason for reaching out was to discuss their publisher's position on AI (50%). Thirty-three percent said the reason was to discuss how they can use AI in their works or contract clauses related to AI. Of those respondents who said their publishers reached out to them about AI, 50 percent said the primary reason for reaching out was to discuss their position on AI. Forty-two percent of respondents said it was to discuss how they can use AI in their works, and 33 percent said it was to discuss contract clauses related to AI.



Only 36 percent of respondents said they felt educated enough about Generative AI to be able to advocate for themselves in conversations with their publishers on the topic.

Only one respondent reported having anything related to AI in their publishing contracts and 32 percent said they didn't know if *continued on page 7*

Considering Writing a Textbook? Questions to Ask

In her November 9, 2022, TAA webinar, "Textbook Authoring Inspirations, Insights, and Innovations", award-winning textbook author Jamie Pope shared several questions you should ask yourself before writing a textbook. Those questions include:

- What's the book's primary focus and level?
- Who's your target audience?
- What are your qualifications to author the book?
- How does it differ from other books on the market?
- Why would someone adopt it over your competitors?

She used these questions to contrast what went right with her successful textbook, *Nutrition for a Changing World*, the recipient of a 2020 TAA Textbook Excellence Award, and what went wrong with a creative trade book proposal that was never published.

What's the Book's Focus

Pope described the focus of her trade book idea as a light and humorous but foundational approach to nutrition basics. The

book's focus, developed in the 90s along with a humorist book co-author, was on fifty weight management tips based in evidence, each illustrated with a cartoon. The book, and especially the title, she said, wouldn't go over well today.

> Her textbook's focus, however, was quite different and more conventional for an academic intro to nutrition textbook than her trade book idea. Quite a few

introductory textbooks were already on the market, she said, some of which were doing exceptionally well. What made hers different was the approach and journalistic style: "It was targeted differently, and truly aimed for student engagement."

Who's Your Target Audience

The primary audience for her textbook was initially for students not necessarily majoring in nutrition, but those who were taking it out of general interest or as a prerequisite in another area. Other books on the market were more "heavy-hitting" and geared towards nutrition majors. However, as the textbook progressed into later editions and was widely adopted, it "branched out into mixed-majors and even majors in the evolution of the text," she said. With her trade book, however, there didn't seem to be a welldefined target audience. "Through my literary agent and based on the success of my previous trade books, numerous publishers looked at it, but none ended up going with it even though some editors called me to talk about, because in part there wasn't a good fit for this book," she said. "It didn't fit in how-to, it didn't fit in humor, and you couldn't give it as a gift to somebody." As a result, she said, it never got published, even though editors thought it was an interesting and unique concept.

What Are Your Qualifications

In the 80s and 90s, before she was working on her trade book, Pope, a registered dietitian nutritionist, had written and coauthored several articles and books in the diet and nutrition arena. By 2012, she had become an assistant professor teaching introductory nutrition, was honing her educator skills, and had continued to publish academically. Her publishing experience, along with more than a decade of teaching with various textbooks set the stage to take on the challenge of authoring a textbook that would meet learning objectives while keeping students interested and engaged.


How Does it Differ from Other Books on the Market

Her trade book was certainly different from other books on the market, but there wasn't a clear sales category for it. While there were competitors in the introductory market, her textbook had enough unique attributes to set it apart from the competition. "We use a story-based approach to provide context and relevance for the science, more visuals and infographics, and organized it in such a way to maximize student engagement and understanding," she said.

Why Would it be Adopted Over Competitors

For instructors, considering a change from a textbook they use in their course can be a big deal, often requiring the revamping of resources, slides, and other teaching tools, said Pope. They often question whether it is worth changing, so as an author, you need to consider how you can both interest and support instructors in making a change. "That was a big thing to me in 2012 when we first started working on this book," she said. "I was teaching with another [textbook] and they came to me about writing this intro text, and I was like 'why would I change, and why would other instructors change?' So, a big thrust throughout has been providing resources, slides, samples, syllabi, everything we can think of to make that ease of transition better and easier for folks." And now with evolving digital platforms, that transition is becoming smoother.

In summary, asking yourself these vital questions before writing a textbook can save you a lot of time and headache. she says. "Obviously, they know their disciplines very well and they most often have a clear research study, but really helping them to meet the standards of academic writing at a late stage can be a huge challenge."

Dr. DeRome Osmond Dunn, an associate professor of mechanical engineering at North Carolina A&T University, said writing should be part of the learning process and happen all along the way. "It's a chance to reflect, and I found that when I started writing, when I started making my charts, graphs and visuals, thoughts came to mind about certain things I could do or things that I didn't need to do," he says. "So that reflection process incorporated by writing should happen early on. It shouldn't be that you do all the work and then you sit down and write. It should be continuous. We learn that in engineering everything is iterative. That's part of the solution process. If you don't iteratively include the writing into your work, you're missing out on doing great work."

Following up on Prof. Dunn's statement, writing coach and editor Dr. Dave Harris, with Thought Clearing, said: "What we're really doing as researchers, is we're trying to think. Often people say, 'Well, I'll do the thinking, I'll do the research, and then I'll write later,' but **writing**, as DeRome suggested, **is a tool that helps you think better**. When you try and write it down, it forces you to think through things."

Dissertation Proposals: When Stating Purpose of Study, Keep it Narrow, Focused, Practical

Dr. Laura Markos, owner, writing coach, and editor at WrittenHouse, and founder of Sage's *Journal of Transformative Education*, shares the following advice for stating the purpose of the study in a dissertation proposal:



"When crafting the dissertation proposal, it's

important to focus, focus, focus on the research question(s) as narrowly as appropriate, but also on the statement of the purpose of the study, which has implications for both theory and practice. It can be tempting to overstate the purpose, to make the study sound like a larger potential contribution than one discrete, doable study. When stating the purpose of the study, my advice is to keep it narrow and absolutely focused on the research question that's agreed upon with committee, and to be practical about the viability and realistic applicability of the study." •

Instead, at your self-promised times, you'll be attending dissertation seminars, studying your university dissertation template, making notes, or surfing the Internet-for scholarly materials. On weekends, rather than car tinkering, sports cheering, or friendly spats with your spouse, you'll still be studying, amassing too many articles, reading all of them, and sneaking up on actually writing.

Get Support. To help, get support. Talk to your cohort members, recent "doctors," professors, and scholars. You'll no doubt hear their horror stories but should also glean some ideas about how to best handle your time. Some students arrange a dissertation "buddy system": you and another doctoral student check in regularly on your progress and encourage and prod each other to keep going.

Talk to your family members and ask their cooperation. Explain why you must hole up most of the time and how they too will benefit later.

So, use the methods here that work best for you and others you may devise. With smart decisions and wise planning, you will rethink your lifestyle so you can start-and finish-your dissertation.

they did. The one respondent who had something related to AI in their publishing contracts said: "I must agree to follow their global AI policy, which mostly concerns a ban on using any of my textbook content to train an AI system."

Fifty-eight percent of all respondents are textbook authors.

Survey responses will also be used in preparation for future TAA virtual roundtable discussions on generative AI. The majority of respondents (60%) said they would be interested in participating in such discussions.

The survey was sent to TAA members, former members, prospective members and shared on TAA social media; and a total of 89 survey responses were received.

Sign On to Class Action Complaint Against Open AI and Microsoft

Susman Godfrey L.L.P. filed a class action complaint against open AI (the makers of ChatGPT) and Microsoft for damages related to their "large-scale infringement of their copyrighted works, as well as injunctive relief." TAA Member Receives Research Grant From NSF for Wiki Education Projects



TAA Member Dr. Brian R. Shmaefsky, Professor of Biology & Environmental Science at Lone Star College - Kingwood, received a research grant from the National Science Foundation (NSF) to engage students from a Hispanic-serving institution to write Wikipedia biographical entries of Hispanic scientists who are underrepresented in Wikipedia. The goal is to improve the visibility and reduce

citation inequity of scientists from marginalized populations. As part of the Wiki Education project, students do background research about the scientist using primary sources, learn to write for an international audience, learn to respond to subject matter expert reviews, learn how to conduct peer reviews, and gain information literacy skills. The program provides students with a detailed schedule of training activities to facilitate the completion of the projects. The goal of the project is to help "students gain key 21st century skills like media literacy, writing and research development, and critical thinking, while content gaps on Wikipedia get filled thanks to students' efforts."

The program is being used by dozens of universities. The concept is a follow-up of several NSF-funded Division of Undergraduate Education grants on providing accessibility, equity, and inclusion using Wikipedia and other open-source resources. "We are being awarded \$170 per Wikipedia entry to go towards improving inclusiveness and equity in environmental science education," said Shmaefsky. "One other benefit of the project is that my students are learning how to search and simplify primary resource academic publications." Congratulations Brian!
